BY-LAW NO. 23-2000

BEING A BY-LAW TO AMEND DOG BY-LAW NO. 119-97 (P14)

WHEREAS By-law No. 119-97 was passed by the Municipal Council of the Town of Fort Erie on the 18th day of August 1997 to regulate, restrict and prohibit the keeping and running at large of dogs in the Town of Fort Erie, and

WHEREAS Report No. PALS-01-2000 was approved as amended at the Council-in-Committee meeting of February 7th, 2000 to amend Sections 19 (a) and (b) under By-law No. 119-97 to prohibit dogs in all parks, cemeteries and beaches within the Town of Fort Erie with the exception of the following parks and trails, to post stoop and scoop signs and to authorize the Town's By-law Enforcement Officers to assist the S.P.C.A. in the enforcement of the dog by-law in Town parks only:

- ◆ Lions Sugar Bowl Park
- ◆ Battle of Ridgeway Park
- ◆ Friendship Trail
- ◆ Friendship Trail portion only of Waverly Beach Park, and

WHEREAS it is deemed desirable to amend Dog By-law No. 119-97 accordingly;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

(1) **THAT** Section 19(a) of By-law No. 119-97 be and it is hereby amended by deleting same in its entirety and inserting in lieu thereof the following:

19. (a) No owner shall permit any dog to be on or in any Town-owned cemetery, public beach or public park within the Town of Fort Erie, except:

- ◆ Lions Sugar Bowl Park
- ◆ Battle of Ridgeway Park
- ◆ Friendship Trail
- ◆ Friendship Trail portion only of Waverly Beach Park

(2) **THAT** the Parks and Leisure Services Department shall erect properly worded signs in the parks set out in Section 1 above to advise of the stoop and scoop provisions of By-law No. 119-97.

- (3) THAT the Town's By-law Enforcement Officers shall assist the Fort Erie S.P.C.A. in the enforcement of Dog By-law No. 119-97 as amended insofar as it relates to Town parks only.
