2000 SERVICES FOR GROUP A – WATERLOO
STREET/FORSYTHE STREET RECONSTRUCTION
AND DOUGLASTOWN PUMPING STATION
UPGRADE TO ROBERT M. MARTIN
ENGINEERING & PROJECT MANAGEMENT INC.

WHEREAS under Report No. PW-08-2000 Council authorized staff to conduct the proposal call for engineering services for 2000 Capital Projects Group A – Waterloo Street/Forsythe Street Reconstruction and Douglastown Pumping Station Upgrade and Group B – Douglas Street Sanitary Sewer Replacement and Daytona Drive Storm Sewer, and;

WHEREAS the proposal call for engineering services for 2000 Capital Projects Group A and B were advertised in the local newspaper and notice was given to the Niagara Chapter of the Consulting Engineers of Ontario, and;

WHEREAS Report No. PW-18-2000 was accepted and approved at the Council-in-Committee meeting on April 17, 2000 authorizing the retention of Robert M. Martin Engineering & Project Management Inc. of St. Catharines, Ontario for Engineering 2000 Services - Group A – Waterloo Street/Forsythe Street Reconstruction and Douglastown Pumping Station Upgrade at the upset limit of \$113,692.85 including 7% G.S.T., and;

WHEREAS the Agreement annexed hereto as Schedule "A" has been reviewed and the terms and conditions are agreeable to the parties.

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:


- 1) THAT** the retention of Robert M. Martin Engineering & Project Management Inc. to provide 2000 Engineering Services for Group A – Waterloo Street/Forsythe Street Reconstruction and Douglastown Pumping Station Upgrade at the upset limit of \$113,692.85 including 7% G.S.T. be and it is hereby approved and authorized.
