BY-LAW NO. 95-2000

**BEING A BY-LAW TO AUTHORIZE AN EXTENSION AGREEMENT  
WITH DUNN THE MOVER LIMITED TO PROVIDE A  
TRANSIT SERVICE FOR THE TOWN OF FORT ERIE (L04.131)**

**WHEREAS** By-law No. 62-97 was passed by the Municipal Council of the Town of Fort Erie on April 14<sup>th</sup>, 1997 authorizing the entry into an agreement with Dunn The Mover Limited for the provision of transit services for the term May 1, 1997 to April 30, 2000, and

**WHEREAS** in view of the expiration of the agreement with Dunn the Mover Limited on April 30, 2000, it is deemed expedient to enter into an extension agreement with Dunn the Mover Limited according to the terms and conditions set out in Schedule "A" annexed hereto to this by-law;

**NOW THEREFORE** the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. THAT the entry into an extension agreement with Dunn the Mover Limited in the form of Schedule "A" annexed hereto to this by-law be and it is hereby approved and authorized.
2. THAT the Mayor and Clerk be and they are hereby authorized and directed to execute the extension agreement annexed hereto as Schedule "A" to this by-law and to affix the Corporate Seal thereto.
3. THAT the provisions of Tendering By-law No. 191-95 be and they are hereby waived.

**THE CORPORATION OF THE TOWN OF FORT ERIE**  
(hereinafter called the "Town")

- AND -

**DUNN THE MOVER LIMITED**  
(hereinafter called "Dunn the Mover")

WHEREAS By-law No. 62-97 was passed by the Municipal Council of the Town of Fort Erie on the 14<sup>th</sup> day of April, 1997 authorizing the entry into an agreement with Dunn the Mover Ltd. for Transit Services, and

WHEREAS the Town and Dunn the Mover entered into an agreement on May 2, 1997 to provide a public bus transportation system within certain areas on certain highways situated in the Municipality for the term May 1<sup>st</sup>, 1997 to April 30<sup>th</sup>, 2000, and

WHEREAS it is deemed expedient to extend the terms and conditions of the said agreement with Dunn the Mover for the supply of transit services from May 1<sup>st</sup>, 2000 to September 1<sup>st</sup>, 2000.

The parties hereby agree that in consideration of the mutual covenants hereinafter given between the parties and other good and valuable consideration, the parties agree as follows:

**1. EXTENSION OF AGREEMENT**

The parties hereby agree to extend the agreement entered into between the Town and Dunn the Mover on May 2<sup>nd</sup>, 1997 according to the same terms and conditions save and except the following:

- 1.1 To amend Article 2 therein by deleting the words "for a term of three (3) Years" in the third line, and inserting in lieu thereof the words "for a term of three (3) years and four (4) months".
