2000 SERVICES FOR GROUP C – CRYSTAL
BEACH AND BAY BEACH SANITARY SEWER
REHABILITATION AND STORM DRAINAGE
IMPROVEMENT – PHASE I, PHASE 2 AND
PHASE 3 TO EARTH TECH CANADA INC. (E00.07)**

WHEREAS under Report No. PW-08-2000 Council authorized staff to conduct the proposal call for engineering services for 2000 Capital Projects Group C – Crystal Beach Central and Bay Beach Sanitary Sewer Rehabilitation and Storm Drainage Improvement – Phase 1, Phase 2 and Phase 3, and;

WHEREAS the proposal call for engineering services for 2000 Capital Projects Group C was advertised in the local newspaper and notice was given to the Niagara Chapter of the Consulting Engineers of Ontario, and;

WHEREAS Report No. PW-19-2000 was accepted and approved at the Council-in-Committee meeting on May 1, 2000 authorizing the retention of Earth Tech Canada Inc. of St. Catharines, Ontario for Engineering 2000 Services - Group C – Crystal Beach Central and Bay Beach Sanitary Sewer Rehabilitation and Storm Drainage Improvement – Phase 1, Phase 2 and Phase 3 at the upset limit of \$210,019.60 including 7% G.S.T., and;


WHEREAS the Agreement annexed hereto as Schedule “A” has been reviewed and the terms and conditions are agreeable to the parties.


NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

- 1) **THAT** the retention of Earth Tech Canada Inc. to provide 2000 Engineering Services for Group C – Crystal Beach Central and Bay Beach Sanitary Sewer Rehabilitation and Storm Drainage Improvement – Phase 1, Phase 2 and Phase 3 at an upset limit of \$210,019.60 including 7% G.S.T. be and it is hereby approved and authorized.

- 2) THAT the Mayor and Clerk be and they are hereby authorized to execute the Agreement annexed hereto as Schedule "A" to this By-Law.
