WHEREAS Tenders were advertised and publicly opened on May 10, 2000 for the following:

1. 1 2000 Mini Van, 6 passenger, 6 cylinder, automatic, - Contract No. FM-02-2000 for the Fire Department;
2. 1 2000 Compact Car, 5 passenger, 4 cylinder, automatic – Contract No. FM-03-2000 for the Planning and Property Safety Department;
3. 2 2000 Full Size Pick-Up Trucks, 6 cylinder, automatic, 2 wheel drive – Contract No. FM-04-2000 for the Public Works – Operations Division;
4. 1 2000 Full Size Pick-Up Truck with Extended Cab, 8 cylinder, automatic, 2 wheel drive – Contract No. FM-05-2000 for the Parks and Leisure Services Department.

WHEREAS Council-in-Committee at its meeting of May 15, 2000 accepted and approved Report PW-20-2000 and authorized the following:-


1. That Contract No. FM-02-2000 Mini Van be awarded to Autoland Chrysler (1981) Ltd. in the amount of \$23,431.25;
2. That Contract No. FM-03-2000 Compact Car be awarded to Dave Lyons Chevrolet Oldsmobile Ltd. in the amount of \$18,180.35;
3. That Contract No. FM-04-2000 2 Pick-up Trucks be awarded to Autoland Chrysler (1981) Ltd. in the amount of \$45,659.60;
4. That Contract No. FM-05-2000 Pick-up Truck with Extended Cab be awarded to Al Slattery Ford in the amount of \$27,843.80.

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

- 1) **THAT** the Tender for a 2000 6 passenger, 6 cylinder, automatic Mini Van – Contract No. FM-02-2000 received from Autoland Chrysler (1981) Ltd. in the amount of \$23,431.25 including G.S.T. and P.S.T., be and it is hereby accepted and approved.
- 2) **THAT** the Tender for a 2000 5 passenger, 4 cylinder, automatic Compact Car – Contract No. FM-03-2000 received from Dave Lyons Chevrolet Oldsmobile Ltd. in the amount of \$18,180.35 including G.S.T. and P.S.T., be and it is hereby accepted and approved.

- 3) **THAT** the Tender for 2 2000 6 cylinder, automatic, 2 wheel drive Pick-up Trucks – Contract No. FM-04-2000 received from Autoland Chrysler (1981) Ltd. in the amount of \$45,659.60 including G.S.T. and P.S.T., be and it is hereby accepted and approved.
- 4) **THAT** the Tender for an 8 cylinder, automatic, 2 wheel drive 2000 Pick-up Truck – Contract No. FM-05-2000 received from Al Slattery Ford in the amount of \$27,843.80 including G.S.T. and P.S.T., be and it is hereby accepted and approved.
- 5) **THAT** should it be necessary, the Mayor and Clerk be and they are hereby authorized to execute any required documentation to effect the acquisition of these vehicles.
