BY-LAW NO. 124-2000

**BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 2000-89 –
TEMPORARY PARKING RESTRICTIONS DURING LOCH SLOY
HIGHLAND GAMES 2000 (210401)**

WHEREAS By-law No. 2000-89 as amended provides for the regulation of traffic and parking on the highways of the Town of Fort Erie, and

WHEREAS in order to provide for emergency vehicle access during the Loch Sloy Highland Games 2000, it is deemed expedient to temporarily restrict parking on the highways identified hereunder for the times and dates stated:

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

- (1) **THAT** By-law No. 2000-89 be and it is hereby amended under Schedule "C" by adding the following thereto in order to provide for emergency vehicle access on June 17th and 18th, 2000:
