BY-LAW NO. 125-2000

**BEING A BY-LAW TO AMEND BY-LAW NO.
113-2000 BEING A BY-LAW TO AWARD
TENDERS FOR VEHICLE ACQUISITION –
CONTRACT NOS. FM-02-2000, FM-03-2000,
FM-04-2000 AND FM-05-2000**

WHEREAS By-Law No. 113-2000 Being a By-Law to Award Tenders for Vehicle Acquisition – Contract Nos. FM-02-2000, FM-03-200, FM-04-2000 and FM-05-2000 was passed on the 23rd day of May 2000, and;

WHEREAS Autoland Chrysler (1981) Ltd., the low bidder on FM-02-2000 Mini Van for the Fire Department have advised that they are unable to provide the vehicle as tendered in the amount of \$23,431.25 including taxes, and;

WHEREAS Council-in-Committee at its meeting of June 5, 2000 accepted and approved Report PW-23-2000 which recommended the award of Tender FM-02-2000 to the second low bidder, Patterson Chrysler Jeep Eagle at the tendered price of \$24,248.90 including taxes, and;

WHEREAS it is deemed necessary and expedient to amend By-Law No. 113-2000 by deleting reference to the award of Tender FM-02-2000 to Autoland Chrysler (1981) Ltd. and inserting in lieu thereof the award of Tender FM-02-2000 to Patterson Chrysler Jeep Eagle.

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

- 1) **THAT** By-Law No. 113-2000 be and is herewith amended by rescinding the award of Tender FM-02-2000 for a 2000 6 passenger, 6 cylinder, automatic Mini Van – Contract No. FM-02-2000 to Autoland Chrysler (1981) Ltd. and awarding the Tender to the second low bidder Patterson Chrysler Jeep Eagle at the tendered price of \$24,248.90 including taxes.
- 2) **THAT** should it be necessary, the Mayor and Clerk be and they are hereby authorized to execute any required documentation to effect the acquisition of this vehicle.
