BY-LAW NO. 157-2000

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 2000-89 RESPECTING TEMPORARY PARKING RESTRICTIONS AND TO PROVIDE FOR TEMPORARY ROAD CLOSURES DURING THE 2ND ANNUAL LABOUR DAY FAMILY PICNIC AND FIREWORKS (210401)

WHEREAS Section 207(44) of the *Municipal Act*, R.S.O. 1990, Chapter M.45 as amended provides that by-laws may be passed by council for closing to vehicular traffic on a temporary basis for such period as shall be specified in the by-law any highway or portion of a highway under the jurisdiction of the council for such social, recreational, community or athletic purpose, or combination of such purposes, as may be specified in the by-law, and

WHEREAS By-law No. 2000-89, as amended provides for the regulation of traffic and parking on the highways of the Town of Fort Erie, and

WHEREAS in order to provide for emergency vehicle access and a public fireworks display during the Labour Day Family Fireworks Day Celebrations, it is deemed expedient to temporarily restrict parking and to temporarily close certain highways identified hereunder on Saturday, September 2nd, 2000, with a raindate of Sunday, September 3, 2000;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

(1) THAT By-law No. 2000-89 be and it is hereby amended under Schedule "C" by adding the following thereto in order to provide for emergency vehicle access on September 2, 2000 (rain date of Sunday, September 3, 2000) during the Labour Day Family Fireworks Day Celebrations

- (2) THAT the following streets be and they are hereby temporarily closed to vehicular traffic from 8:00 p.m. to 10:00 p.m. Saturday, September 2, 2000, (rain date September 3, 2000) all of which is in conjunction with the Labour Day Family Fireworks Day Celebrations;
 - > Intersection of Beatrice Street and Lakeshore Road
 - > Intersection of Dominion Road and Lakeshore Road
 - > Intersection of Drummond Crescent and Lakeshore Road
- (3) **THAT** the Town of Fort Erie shall supply the barriers to Friendship Festival for Saturday, September 2, 2000, to temporarily close the above named streets, however, Friendship Festival shall be responsible for erecting and maintaining the signs pursuant to the Town's instructions.
- (4) **THAT** the Friendship Festival shall provide to the Clerk of the Corporation of the Town of Fort Erie liability insurance for this event, ten days prior to the date of the event, in the amount of Two Million Dollars (\$2,000,000.00) naming the Town as additional insured.
- (5) THAT the Corporation of the Town of Fort Erie shall provide and keep in repair a reasonable temporary alternative route for traffic and for all property owners who cannot obtain access to their property by reason of such closing, where appropriate.
- (6) **THAT** the Town shall supply and the Friendship Festival shall erect at each end of each highway temporarily closed by this by-law and where an alternative route deviates therefrom, a barricade upon which an adequate warning device shall be exposed and there shall be erected at such points a detour sign indicating the alternative route and containing a notice that the highway is closed to vehicular traffic, where appropriate.
- (7) **THAT** every person who uses any part of any highway temporarily closed by this by-law does so at his own risk and the Corporation of the Town of Fort Erie shall not be liable for any damages sustained by any person using the highway or a portion thereof so temporarily closed to traffic.

(8) THAT every person who contravenes any provision of this by-law is guilty of an offense and upon conviction thereof, shall forfeit and pay at the discretion of the presiding Judge or Justice of the Peace a penalty not exceeding (exclusive of costs) the sum of \$5,000.00 for each offense and every such fine is recoverable under the Provincial Offenses Act.
