BY-LAW NO. 159-2000

BEING A BY-LAW TO ESTABLISH ADVANCE VOTING AND REDUCED HOURS OF VOTING FOR INSTITUTIONS/RETIREMENT HOME ELECTORS FOR THE 2000 MUNICIPAL ELECTIONS (3202)

WHEREAS Section 43(1) of the *Municipal Elections Act*, 1996 Chapter 32, R.S.O., 1996 provides interalia that Council shall pass a by-law establishing the times and dates for advance voting more than 30 days prior to voting day, and

WHEREAS Section 46(3) of the said Municipal Elections Act, provides interalia that council may pass a by-law providing for reduced hours of voting places in institutions and retirement homes, and

WHEREAS at the Committee of the Whole meeting of August 21, 2000, Report No. F-37-1-2000 was approved authorizing advance voting for the 2000 Municipal Elections as well as reduced hours for voting places in institutions and retirement homes, and

WHEREAS it is deemed desirable to effect the above;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

(1) THAT the following dates and times be and they are hereby established for advance voting and reduced hours of voting for institutional and retirement homes during the 2000 Municipal Elections in the Town of Fort Erie:
