



# **The Municipal Corporation of the Town of Fort Erie**

**BY-LAW NO. 172-2000**

---

**BEING A BY-LAW TO ESTABLISH THE ANNUAL ALLOWANCE  
FOR MAYOR AND MEMBERS OF COUNCIL AND TO REPEAL BY-  
LAW NO. 10-99 EFFECTIVE DECEMBER 1, 2000 (2501)**

---

**WHEREAS** Section 242(1) of the Municipal Act, R.S.O. 1990, Chapter M.45 as amended provides despite any general or special act, the council of the municipality may pass by-laws for paying remuneration to the members of council and such remuneration may be determined in any manner that council considers advisable, and

**WHEREAS** Section 242(2) of the said Municipal Act provides that the remuneration to be paid may be determined in different manners and be of different amounts for different members of council, and

**WHEREAS** By-law No. 10-99 provides for the annual allowance for Mayor and Members of Council, and

**WHEREAS** at the Council-in-Committee meeting of September 18, 2000 the recommendation under F-45-2000 was approved to adjust the annual remuneration for (6) Councillors to the average councillor remuneration of the area municipalities, being \$9,472.46, effective December 1, 2000, and

**WHEREAS** it is deemed desirable to re-establish the annual remuneration for the Mayor and to increase the remuneration for Councillors;

**NOW THEREFORE** the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

- (1) **THAT** the annual remuneration for the Mayor of the Town of Fort Erie shall remain at \$40,523.58.
- (2) **THAT** the annual remuneration commencing December 1, 2000 for the Councillors of the Town of Fort Erie shall be \$9,472.46.
- (3) **THAT** the annual allowance for the Mayor and Councillors of the Town of Fort Erie shall be increased on an annual basis according to the annual percentage increase granted to management and supervisory employees of The Corporation of the Town of Fort Erie, if that be the case.

- (4) THAT By-law No. 10-99 be and it is hereby repealed.
- (5) THAT the provisions of this by-law shall not come into force and effect until December 1, 2000 and in the interim, the following annual remunerations shall apply:

Head of Council	\$40,523.58
Councillors	\$ 8,155.22
