BY-LAW NO. 190-2000

BEING A BY-LAW TO TEMPORARILY CLOSE CERTAIN TOWN STREETS DURING 2000 CHAMBER OF COMMERCE SANTA CLAUS PARADE (210401)

WHEREAS Section 207(44) of the Municipal Act, R.S.O. 1990, Chapter M.45 as amended provides that by-laws may be passed by council for closing to vehicular traffic on a temporary basis for such period as shall be specified in the by-law any highway or portion of a highway under the jurisdiction of the council for such social, recreational, community or athletic purpose, or combination of such purposes, as may be specified in the by-law, and

WHEREAS it is deemed desirable to temporarily close certain streets under the jurisdiction of the Town of Fort Erie during the marshalling period and conduct of the 2000 Chamber of Commerce Santa Claus Parade as well as restricting parking on the north side of Jarvis Street;

NOW THEREFORE the Municipal Council of the Town of Fort Erie enacts as follows:

1. **THAT** the following streets be and they are hereby temporarily closed to vehicular traffic from 12:30 p.m. to 4:30 p.m., Saturday, November 25, 2000 in order to provide a marshalling area for the 2000 Chamber of Commerce Santa Claus Parade:

Jarvis Street from the Niagara Boulevard to Central Avenue;
Courtwright Street and Dufferin Street

2. **THAT** the following streets be and they are hereby temporarily closed to vehicular traffic from 3:30 p.m. to 5:30 p.m. on Saturday, November 25, 2000 only inasmuch as the parade affects the roads during the period:

South on Central Avenue to Gilmore Road
East on Gilmore Road to Niagara Boulevard
South on Niagara Blvd. to Mathers Arch

3. **THAT** parking on both sides of Jarvis Street between the Niagara Boulevard and Central Avenue be temporarily prohibited between the hours of 3:30 p.m. and 4:30 p.m. on Saturday, November 25, 2000 in order to accommodate the 2000 Chamber of Commerce Santa Claus Parade.

4. **THAT** the Corporation of the Town of Fort Erie shall provide and keep in repair a reasonable temporary alternative route for traffic and for all property owners who cannot obtain access to their property by reason of such closing, where appropriate.


5. **THAT** there shall be erected at each end of each highway temporarily closed by this by-law and where an alternative route deviates therefrom, a barricade upon which an adequate warning device shall be exposed and in good working order continuously during the temporary road closures and there shall be erected at such points a detour sign indicating the alternative route and containing a notice that the highway is closed to vehicular traffic.


6. **THAT** the Greater Fort Erie Chamber of Commerce shall provide to the Clerk of the Corporation of the Town of Fort Erie liability insurance for this event in the amount of Two Million (\$2,000,000.00) Dollars naming the Town as additional insured.

7. **THAT** every person who uses any part of any highway temporarily closed by this by-law does so at his own risk and The Corporation of the Town of Fort Erie shall not be liable for any damage sustained by a person using the highway or a portion thereof so temporarily closed to traffic.

8. **THAT** every person who without lawful authority uses that portion of any highway so closed to traffic by this by-law or who removes or defaces any barricade, device, detour sign or notice placed thereon by lawful authority, is guilty of an offence and is also liable to The Corporation of the Town of Fort Erie for any damage or injury occasioned by such wrongful use, removal or defacement and upon conviction thereof, shall forfeit and pay at the discretion of the convicting court a penalty not exceeding (exclusive of costs) the sum of \$5,000.00 for each offence and every such fine is recoverable under the Provincial Offences Act.
