BY-LAW NO. 195-2000

**BEING A BY-LAW TO ACCEPT A TENDER FROM
SALCOR CONSTRUCTION LTD. FOR ADDITION/RENOVATIONS
TO FIRE STATION NO. 5 – STEVENSVILLE
(120901)**

WHEREAS during the 2000 budget deliberations \$400,000.00 was allocated from development charges to add on to and renovate Fire Station No. 5 in Stevensville, and

WHEREAS tenders were called for an addition and renovation to Fire Station No. 5 Stevensville on September 5, 2000 with a closing date of September 26, 2000, and

WHEREAS Administrative Report No. PPS-89-2000 was approved at the Council-in-Committee meeting held October 16, 2000, authorizing that Salcor Construction Ltd. of Port Colborne, the low tenderer, be awarded the contract as the general contractor for the Fire Station No. 5 – Stevensville addition/renovations project, and further, to approve the increased expenditure of \$175,000.00 from Fire Department reserve funds to increase the project total to \$575,000.00, and further, that staff be directed to work with Salcor Construction Ltd. to reduce the price of this project as much as is reasonably possible, and further that the deferred items form a part of the 2001 budget deliberations, and

WHEREAS it is deemed desirable to accept the Form of Tender from Salcor Construction Ltd. in the negotiated reduced amount of \$533,863.00 + g.s.t., and to enter into an agreement for the addition/renovations project to Fire Station No. 5 – Stevensville;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. **THAT** the Form of Tender received from Salcor Construction Ltd. in the negotiated reduced amount of \$533,863.00 + g.s.t. for the addition/renovation project to Fire Station No. 5 – Stevensville, in the form of Schedule "A" annexed hereto to this by-law be and it is hereby accepted and approved.
2. **THAT** the entry into an agreement with Salcor Construction Ltd. in the form of Schedule "B" annexed hereto to this by-law be and it is hereby authorized and approved.
3. **THAT** the Mayor and Clerk be and they are hereby authorized and directed to execute the agreement annexed hereto as Schedule "B" and to affix the corporate seal thereto.

Development Charges Reserve	\$400,000.00
Fire Department Reserve Account	\$175,000.00
