BY-LAW NO. 197-2000

**BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 2000-89 – ONE
HOUR PARKING – JARVIS STREET AND TO REPEAL
BY-LAW NO. 149-96**

WHEREAS By-law No. 2000-89 as amended provides for the regulation of traffic and parking on the highways of the Town of Fort Erie, and

WHEREAS Schedule “E” to By-law No. 2000-89 as amended sets out limited parking for Jarvis Street, and

WHEREAS By-law No. 128-96 was passed by the Municipal Council of the Town of Fort Erie on the 17th day of June 1996 to provide for one hour parking on Jarvis Street, and

WHEREAS it is now desirable to amend Schedule “E” in part, to reflect two hour parking between the Niagara Boulevard and 100 metres west of Central Avenue on both sides of Jarvis Street between the hours of 9:00 a.m. to 6:00 p.m. Monday through Saturday;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. **THAT** Schedule “E” (limited parking) to By-law No. 2000-89 as amended be and it is hereby further amended save and except those areas on the south side of Jarvis Street so designated as limited parking, by adding the following thereto:

STREET	SIDE	BETWEEN	TIMES OR DAYS	MAXIMUM PERIOD PERMITTED
Jarvis Street	North	West limit Niagara Boulevard and 100 metres West of Central Avenue	Monday to Saturday 9:00 a.m. to 6:00 p.m.	Two (2) Hours
Jarvis Street	South	West limit Niagara Boulevard and East limit Central Avenue	Monday to Saturday 9:00 a.m. to 6:00 p.m.	Two (2) Hours
Jarvis Street	South	West limit Central Avenue from a point 23.5 m westerly 75 metres	Monday to Saturday 9:00 a.m. to 6:00 p.m.	Two (2) Hours

2. **THAT** By-law No. 149-96 be and it is hereby repealed.
3. **THAT** this by-law shall come into effect upon the erection of the properly worded signs.
