**BY-LAW NO. 216 –2000**

**BEING A BY-LAW TO AMEND BY-LAW NO. 62-98,  
BEING THE AGREEMENT WITH THE CITY OF ST. CATHARINES  
FOR COMPUTER AIDED DISPATCH SERVICES  
FOR THE TOWN OF FORT ERIE FIRE DEPARTMENT (120905)**

---

**WHEREAS** By-law No. 62-98 passed by the Municipal Council of the Town of Fort Erie on the 27<sup>th</sup> day of April, 1998, authorizes the entry into an agreement with the City of St. Catharines for computer aided dispatch services for the Fort Erie Fire Department, and

**WHEREAS** the term of the aforementioned agreement commenced on the first day of January on 1997 and is due to expire on the 31<sup>st</sup> day of December, 2000, and

**WHEREAS** the City of St. Catharines, in consideration of the Niagara Fire Services involvement with the Niagara Voice Radio Project, is desirous of extending the current agreement for a further one year at an increased cost of CPI supplement of 2.3% and the Town of Fort Erie Fire Department is desirous of extending the said agreement for a further one year; and

**WHEREAS** as a result of these amendments, it is deemed necessary and expedient to amend the agreement for Computer Aided Dispatch Services for the Town of Fort Erie;

**NOW THEREFORE** the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. **THAT** the entry into the Addendum No. 1 with the City of St. Catharines for Computer Aided Dispatch services for the Fort Erie Fire Department in the form of Schedule "A" annexed hereto to this by-law be and it is hereby approved and authorized.

2. **THAT** the Mayor and Clerk be and they are hereby authorized and directed to execute the Addendum No. 1 annexed hereto as Schedule "A" to this by-law and to affix the corporate seal affixed thereto.

**ADDENDUM NO. 1**

THE CORPORATION OF THE CITY OF ST. CATHARINES  
(hereinafter called "St. Catharines")

OF THE FIRST PART

**WHEREAS** the parties entered into an Agreement on the 12th day of May, 1998, and

**WHEREAS** it is deemed desirable by the parties to effect certain amendments to the Agreement for Computer Aided Dispatch Services for the Town of Fort Erie Fire Department, and

**WITNESSETH** that in consideration of the fees, covenants and agreements reserved in the Agreement between St. Catharines and Fort Erie dated the 12<sup>th</sup> day of May, 1998, (hereinafter called the "agreement"), the parties hereby agree to amend said agreement as follows:

1.     THAT Clause 1 be and it is hereby amended by deleting the words "31<sup>st</sup> day of December, 2000" in the last line thereof and inserting in lieu thereof, the words "31<sup>st</sup> day of December, 2001".
2.     THAT Clause 2 be amended by deleting same in its entirety and adding the following in lieu thereof:

    "2. Fort Erie agrees that it shall be responsible for the following:

- a) That for the year 2001, Fort Erie shall pay the City of St. Catharines the annual amount of \$55,183.00 plus all applicable taxes, to be payable in full by December 31, 2001."

3. THAT Clause 3 be and it is hereby amended by deleting same in its entirety and inserting in lieu thereof the following:

“3. Fort Erie shall pay St. Catharines in the following manner:

The said amount of \$55,183.00 plus all applicable taxes, shall be payable in four equal payments of \$13,795.75 plus all applicable taxes, payable every three months being the first day of January, 2000, the first day of April, 2000, the first day of July, and the first day of October, 2000.”
