BY-LAW NO. 217-2000

### BEING A BY-LAW TO AMEND BY-LAW NO. 22-98 (TO AUTHORIZE AND APPROVE AN AGREEMENT WITH THE FORT ERIE SOCIETY FOR THE PREVENTION OF CRUELTY TO ANIMALS FOR THE PROVISION OF ANIMALS CONTROL SERVICES) TO EXTEND THE TERM OF THE AGREEMENT (120905)

WHEREAS By-law No. 22-98, being a by-law to authorize and approve an agreement with the Fort Erie Society for the Prevention of Cruelty to Animals for the provision of animal control services, was approved by the Municipal Council of the Town of Fort Erie at its Regular Meeting held the 23<sup>rd</sup> day of February, 1998, and

WHEREAS the subject agreement expires on the 31st day of December, 2000, and

WHEREAS negotiations between the two parties are ongoing, and

WHEREAS it is deemed necessary and expedient to extend the current contract to March 31, 2001;

**NOW THEREFORE** the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

- 1. **THAT** the entry into the Addendum No. 1 with the Fort Erie S.P.C.A. for the provision of animal control services for the Town of Fort Erie in the form of Schedule "A" annexed hereto to this by-law be and it is hereby approved and authorized.
- 2. THAT the Mayor and Clerk be and they are hereby authorized and directed to execute the Addendum No. 1 annexed hereto as Schedule "A" to this by-law and to affix the corporate seal affixed thereto.

WHEREAS the parties entered into an Agreement on the 16<sup>th</sup> day of March, 1998 for the provision of animal control, licensing and Poundkeeper services within the Town of Fort Erie, and

WHEREAS it is deemed desirable by both parties to extend the agreement for the provision of animal control, licensing and Poundkeeper services to the 31<sup>st</sup> day of March, 2001, and

**WITNESSETH** that in consideration of the fees, convenants and agreements reserved in the Agreement between the Town and the SPCA, dated the 16<sup>th</sup> day of March, 1998, (hereinafter called the "agreement"), the parties hereby agree to amend said agreement as follows:

1. THAT Section 3 be and it is hereby amended by deleting the words "December 31, 2000" and inserting in lieu thereof the words "March 31, 2001".
