# THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF FORT ERIE HEREBY ENACTS AS FOLLOWS:

WHEREAS, Section 34, Subsection 1 of the Planning Act R.S.O. 1990, cP 13 authorizes the Council of the Municipality to regulate the use of lands and the character, location and use of buildings and structures within the Municipality, and;

WHEREAS, Section 34, Subsection 12 requires the Municipality before the passing of a by-law under this section of the Act to ensure that sufficient information is made vailable to the public to generally understand the zoning proposal and to hold a public meeting, and;

WHEREAS, in accordance with Section 34, Subsection 17 where changes have been made to the by-law after the holding of a public meeting, Council can determine that no further notice is to be given with respect to the by-law;

**NOW THEREFORE,** the Municipal Council of the Corporation of the Town of Fort Erie hereby enacts as follows:

- Schedule A21 of By-law 129-90 is amended by changing the zoning of the lands shown on the attached Schedule A from "Rural RU Zone to Estate Residential Holding ER(H)-236 Zone" which attached Schedule A is hereby declared to form part of this by-law.
- 2. By-law 129-90 is amended by adding to Subsection Schedule A21 of Section 35 (Exceptions) thereto the following exceptions:
  - ER(H) 236 These lands are zoned "Estate Residential Holding ER(H)-236 Zone" and all of the provisions of By-law 129-90 as amended that relate to lands zoned "Estate Residential ER Zone" by that By-law shall apply to those lands zoned Estate Residential Holding ER (H) 236 Zone on Schedule A21. Once the Holding has been removed after the owners have entered into a sub-division agreement with Council, the development of these lands shall comply with all of the provisions of By-law 129-90 as amended that relate to lands zoned "Estate Residential ER Zone" by that by-law.

- 3. In the public notice and at the public meeting the proposed zoning was Estate Residential ER Zone. As a result of comments from the Town Solicitor a Holding Zone should be added to the property and not be removed until the subdivision agreement has been approved. Therefore, Council in accordance with Section 34, Subsection 17 of The Planning Act, R.S.O. 1990 has determined that no further notice will be given with respect to this by-law.
- 4. The lands referred to in Sections 1,2,&3 are situated at the south side of Dominion Road east of Bernard Avenue and consist of Part of Lot 18 Concession 1, LE. designated as Part 2 on 59R-9263 in the former Township of Bertie, now in the Town of Fort Erie, in the Regional Municipality of Niagara.
