

# The Municipal Corporation of the Town of Fort Erie

BY-LAW NO. 151-09

BEING A BY-LAW TO AWARD A TENDER AND AUTHORIZE
THE ENTRY INTO AN AGREEMENT WITH
OMNI FACILITY SERVICES CANADA LIMITED
FOR JANITORIAL SERVICES AT THE LEISUREPLEX,
TOWN HALL, GIBSON CENTRE, CENTENNIAL LIBRARY,
CRYSTAL RIDGE LIBRARY AND STEVENSVILLE LIBRARY

WHEREAS tenders were advertised and publicity opened on Thursday, November 5, 2009 for janitorial services at the Leisureplex, Town Hall, Gibson Centre, Centennial Library, Crystal Ridge Library and Stevensville Library – Contract No. ISF.08-2009, the results of which were as follows:

WHEREAS at the Council-in-Committee meeting held November 16, 2009 Report No. IS-48-09 was accepted and approved awarding the tender to Omni Facility Services Canada Limited for the provision of janitorial services at the Leisureplex, Town Hall, Gibson Centre, Centennial Library, Crystal Ridge Library and Stevensville Library in the amount of \$99,955.80 (including GST) for Year 1 and \$101,955.00 (including GST) for Year 2 – Contract No. ISF.08-2009, and

**WHEREAS** it is deemed desirable to accept the tender from Omni Facility Services Canada Limited for the aforestated works and price;

**NOW THEREFORE** the Municipal Council of the Town of Fort Erie hereby enacts as follows:

- 1. THAT the tender received from Omni Facility Services Canada Limited in the amount of \$99,955.80 (including GST) for Year 1 and \$101,955.00 (including GST) for Year 2 for the provision of janitorial services at the Leisureplex, Town Hall, Gibson Centre, Centennial Library, Crystal Ridge Library and Stevensville Library – Contract No. ISF.08-2009 be and it is hereby accepted and approved.
- 2. THAT the entry into an Agreement with Omni Facility Services Canada Limited for the provision of janitorial services at the Leisureplex, Town Hall, Gibson Centre, Centennial Library, Crystal Ridge Library and Stevensville Library Contract No. ISF.08-2009 in the form of Schedule "A" annexed hereto to this by-law be hereby authorized and approved.

3. THAT the Mayor and Clerk be and they are hereby authorized and directed to execute the Agreement annexed hereto as Schedule "A" to this by-law and affix the corporate seal thereto.

#### ARTICLE A-2 CONTRACT DOCUMENTS

#### ARTICLE A-3 CONTRACT PRICE

(a) Based on the Schedule C – Schedule of pricing, refer to in article A-3 (c) the tender price is Ninety Nine Thousand, Nine Hundred and Fifty Five Dollars and Eighty Cents (\$99,955.80) in Canadian Funds (Including G.S.T.) for Year 1 and;

One Hundred and One Thousand, Nine Hundred and Fifty Five Dollars (\$101,955.00) in Canadian Funds (Including G.S.T.) for Year 2.

#### ARTICLE A-4 PAYMENT

- (a) The Owner shall pay the Contractor in Canadian funds for the performance of the Contract, the amounts in the Schedule C Schedule of Pricing Article A-3 (c) of this Agreement.
- (b) Subject to applicable legislation and the provisions of the Contract Documents where such legislation or regulations do not exist or apply.
- (c) the contractor shall submit monthly invoices equal of 1/12 of the total annual cost for each facility.
- (d) If the Owner fails to make payments to the Contractor as they become due under the terms of this Contract or in an award by arbitration or court, interest of one percent (1%) per annum on such unpaid amounts shall also become due and payable until payment. Such interest shall be calculated and added to any unpaid amounts monthly.

#### ARTICLE A-5 RIGHTS AND REMEDIES

- (a) The duties and obligations imposed by the Contract Documents and the rights and remedies available there under shall be in addition to and not a limitation of any duties, obligations, rights and remedies otherwise imposed or available by law.
  - (b) No action or failure to act by the Owner, Contract Administrator or Contractor shall constitute a waiver of any right or duty afforded any of them under the Contract, nor shall any such action or failure to act constitute an approval of or acquiescence in any breach there under, except as may be specifically agreed in writing.

# ARTICLE A-6 RECEIPT OF AND ADDRESSES FOR NOTICES

Communications in writing between the parties or between them and the Contract Administrator shall be considered to have been received by the addressee on the date of delivery if delivered by hand to the individual or to a member of the firm or to an officer of the corporation for whom they are intended or if sent by fax, to have been delivered within five (5) working days of the date of mailing, or dispatch when addressed as follows:
