BY-LAW NO. 206-2000

**BEING A BY-LAW TO AMEND BY-LAW NO. 185-2000
- TO ESTABLISH A GAMING POLICY FOR THE
TOWN OF FORT ERIE AND TO DELEGATE THE
ADMINISTRATION TO THE COMMUNITY GAMING
DEVELOPMENT CORPORATION (210101)**

WHEREAS By-law No. 185-2000, being a by-law to establish a Gaming Policy for the Town of Fort Erie and to delegate the administration to the Community Gaming Development Corporation was approved by the Municipal Council of the Town of Fort Erie on October 10th, 2000, and

WHEREAS Resolution No. 16 was approved by the Municipal Council of the Town of Fort Erie at its Special Meeting held November 6, 2000, authorizing Council to meet with Alcohol and Gaming Commission of Ontario as soon as possible to resolve issues associated with implementing the Gaming Policy By-law, and

WHEREAS a meeting with the Alcohol and Gaming Commission of Ontario was held on November 10, 2000 wherein amendments were suggested that would resolve the issues associated with implementing the Gaming Policy By-law, and

WHEREAS it is deemed necessary and expedient to make the suggested amendments to By-law No. 185-2000;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. **THAT** Section 4 of Schedule "A" to By-law No. 185-2000 be and it is hereby amended by deleting same in its entirety and inserting in lieu thereof the following:

4.0 Key Functions and Responsibilities of Community Gaming Development Corporation

That in accordance with Section 2 and Section 3 of By-law No. 185-2000, the key functions of the Corporation are as follows:

1. To manage on behalf of Council all aspects of the gaming licensing function including application process, review process, allocation of events, monitoring for compliance, outcomes evaluation and regularly report through the Official to Council recommendations with respect to the issuance of lottery licenses.

2. **THAT** Section 7.3 of Schedule "A" to By-law No. 185-2000 be and it is hereby amended by deleting same in its entirety and inserting in lieu thereof the following:

7.3 Notice of Decision/Recommendation to Council

1. All applicants shall be informed, in writing, regarding decisions of license approval, renewal or amendment. All notices of decision by the Corporation will be incorporated into the minutes and form a recommendation to Council.
 2. Every written notice of decision sent under this By-law shall specify the last date on which a notice of appeal may be filed pursuant to Section 8.2.1. herein.
3. **THAT** Section 19.0 of Schedule "A" to By-law No. 185-2000 be and it is hereby amended by deleting same in its entirety and inserting in lieu thereof the following:

19.0 Minutes and Reports

1. Minutes of all Corporation meetings, including minutes which set out Notices of Decision/recommendations with respect to the issuance of lottery licences, shall be delivered after each meeting to the Clerk of the Town for inclusion on the Regular Council Agenda, for approval purposes.
